## **III. Required documents for application**

- 1. A cover letter indicating for which program of study the application is being made and description of the motivation to join the program
- 2. Detailed curriculum vitae (CV)
- 3. Notarized degree or equivalent from Higher Education Council (HEC)
- 4. Notarized academic transcripts



- 5. Two recommendation letters from academic referees who are knowledgeable about the applicant,
- 6. Copy of national identity card or Passport
- 7. Applicants from countries where English is not the language of instruction in higher education must provide an English proficiency certificate from a relevant body or institution.

The selection will be essentially done by the assessment of submitted documents. Only applicants who meet the entry requirements indicated above and who have submitted all the required documents will be invited for interview.
