The University of Rwanda received financing from the African Development Bank (AfDB) hereinafter called the Bank toward the cost of the Regional Centre of Excellence in Biomedical Engineering and E-Health (CEBE) Project, and intends to apply part of the proceeds toward payments under the contract for Acquisition of Furniture and IT Equipment for CEBE Building. For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing, except for those payments, which the contract provides to be made through letter of credit.
2. The University of Rwanda now invites sealed Bids from eligible Bidders for the Acquisition of Furniture of CEBE Building as detailed in the bidding document.
3. Bidding will be conducted through the Open Competitive Bidding (International), (OCBI) method as specified in the Procurement Policy for Bank Group Funded Operations, dated October 2015 and is open to all eligible bidders as defined in the Procurement Framework.

The bidding document in **English** may be purchased by interested eligible Bidders upon the submission of a written application to the address below and upon payment of a non-refundable fee of **Frw 20,000 or in a convertible currency**. The method of payment will be direct deposit to RRA account (Non fiscal Revenue). The document will be sent by email or **courier**.
5. Bids must be delivered to the address below on or before ¹⁴~~22~~/01/2022 at **10h00 a.m.** local time. Electronic Bidding will **not** be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below ¹⁴on ~~22~~/01/2022 at **10h30a.m. local time**.
6. All Bids must be accompanied by a **Bid Security** of **5,000USD for Lot Two (Supply of IT Equipment)** or in any easily convertible currency.
