- 6. Bids must be delivered to the below address not later 10h00 AM Kigali
  Rwanda time on 31st July 2023. Electronic bidding will not be permitted. Late bids will be rejected;
- 7. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who chooses to attend. The meeting will take place physically at the below mentioned address on 31st July 2023 at 10h30 AM Kigali Rwanda time local time;
- Bids well typed, appropriately bound and presented in three copies (one original and two copies) must be accompanied by a bid guarantee issued by any reputable financial institution of one million eight hundred thousand Rwandan Francs (Frw 1,800,000) or in convertible currency; in sealed envelope and must reach to the Secretariat of the below mentioned address on or before the date and time mentioned in the point 6 and 7. The outer envelope should clearly indicate the tender number and title;
